The budget details were available at the office of the Superintendent during regular business hours.

 - a. The budget hearing was called to order by President Roberts at 7:00 p.m. with members Benson, Werts, Cumming, and Merrell present. Also in attendance were Darren Luebbe, Chris Condreay, and Justin Frederick (via zoom).
