# BOARD OF EDUCATION, BUDGET HEARING AND REGULAR MEETING

St. Edward School Science Room – St. Edward, Nebraska Monday, September 11, 2023, 6:45 p.m.

The St. Edward Public School Board of Education conducted a budget hearing on Monday, September 11, 2023. Advance notice of the meeting was published in The Albion News & Boone County Tribune on September 6, 2023. The purpose of the hearing was to provide the opportunity for taxpayers to provide support, opposition, criticism, suggestions or observations relating to the proposed budget. The budget details were available at the office of the Superintendent during regular business hours.

- 1. Opening Procedures:
  - a. The budget hearing was called to order by President Roberts at 6:45 p.m. with members Christman, Merrell, Cumming, Reardon, and Cruise present. Also present were Stephen Osborn and Lindsay Tenski
  - b. Pledge of Allegiance
  - c. President Roberts stated the hearing will follow the Open Meetings Act, which is located in the meeting room.

Mr. Osborn presented the proposed budget to the board of education and patrons. The proposed budget sets the tax asking at \$3,131,743.00, the General Fund Budget at \$4,893,750.00, Depreciation fund at \$6,210,00, Activity Fund \$186,600.00, School Nutrition \$195,000.00 and the Special Building Fund Budget at \$292,970.00.

- d. The increase in General Fund expenditures is for increase in salaries, health insurance, ESU services, and overall cost due to increased inflation.
- e. The budget hearing adjourned at 6:59 p.m. by executive order.
