Mr. Osborn's Report

<u>Project Updates</u>: We had to have a component replaced in our surveillance camera system and completed that last Friday. The same company is also preparing a bid for the lock entry system into the fitness center and south gymnasium door; We are waiting for a bid on the concrete project outside the elementary entrance.

Staffing: I have offered a part-time instrument music teaching position to John Weidner and he has accepted the position. This is an action item on the agenda: In the vocal music area, Mrs. Osborn will be teaching K-6 music for 40 minutes per day serving two grade levels in each session. (1st & 2nd; 3rd & 4th; 5th & 6th - Kindergarten will be taught separately) During her time teaching music, she will schedule her supplemental activities to be carried out under the direction of one of the two teachers whose students are in music under Mrs. Osborn's direction. She will also be teaching a year-long high school choir class from 7:15 am – 7:45 am 2-3 days per week. We are working on a plan to finish this school year as well as prepare for next year in the area of our paraeducator assistance to students and staff. We continue advertising for a replacement; Certified contracts have been given to the staff and are due back on or before April 15, 2024; We have concluded the process of accepting applications for 2024-2025 winter coaching positions. We will need to interview two candidates for Head Girls Basketball and that will be completed this Wednesday evening; Steve Thompson joined our staff today. He will be working on a part time basis with maintenance and taking on some custodial duties as well. He will be a welcome addition to the staff.
