d. Mr. Osborn's Report

Project Updates

- The tree removal and trimming work is planned to begin after May 16th.
- Glass Edge will begin the door replacement project after the 16th of May.
- Applied Connective is hoping to begin the patron entrance system to the fitness center and gymnasium Thursday or Friday.
- All of the equipment for the Fitness Center has arrived with the exception of the two treadmills. I have an action item on the agenda to increase the amount up to \$11,100.00
- Summer maintenance requests are coming in and are mostly routine requests such as painting and some minor repair type work. The gym floor refinishing is scheduled to take place the first two weeks in July.

Staffing

- Mrs. Osborn will be teaching 6-12 Band next year. This will be taught first period and Mrs. Osborn's 6th grade students will part of the band. She will continue with vocal music as she did this year.
- We are advertising for the art teaching position but are planning to move forward covering in house as the availability of art teachers is much like music teachers. Mrs. Faust will be offering some art courses and Mrs. Tenski is planning to offer a scrapbooking class as an art offering next year as well. Elementary grades will be responsible for incorporating art into their weekly schedules which should not be too difficult. They currently do various art projects during the year.

Other Information:

We are recipients for the “mapping” grant in the amount of \$3,797.00. This is to meet the requirements of policy 3241 Emergency Response Mapping. I am now working with the vendor with details for completing the project, and I will share additional information as it becomes available. We will pay 50% of the cost to start the project and the other 50% upon completion. All funds will be reimbursed.

- We held preschool open house for incoming three-year-olds on Monday, April 7th. We had four families attend and we normally have others that will decide to join between now and the start of the school year. We currently have eight in the three-year-old section and nine in the four-year-old section.
- I have applied for the Fresh Fruit and Vegetable Program Grant for School Year 2025-2026. If selected as recipients, this would be for grades K-6, and we would offer the students fresh vegetables and/or fruits two times per week. This cannot take place during breakfast or lunch or before or after school. If we are selected, I will share more information as far as the amount of the grant and plans for implementation. It would be a great addition for our Wellness Committee to incorporate in our overall wellness activities.

Upcoming Meeting and Conferences:

- Jan is planning to attend the Nebraska Association of School Business Officials again this year. This takes place April 24th and 25th in Lincoln

Board Committee Reports

- The Policy Committee met at the NRCSA Conference and reviewed two, 6000 Series Policies needing updates, and these are action items on the agenda. We are planning to meet again in early June for our annual Perry Policy updates and mandate recommendations
- The Coop Committee met Friday, March 28th and discussed the year in review and the possibility of adding Twin River to our girls wrestling. The addition of baseball with Twin River was discussed but did not gain much traction at this point.
- The Building and Grounds Committee met on Thursday, April 10th to review the PK playground equipment bids. There will be additional costs for the trike trail, chain link fencing, mulch, etc. There is an action item on the agenda.
