These include continuous school improvement process including our number sense and vocabulary goals, inclusion for all students, and MTSS activities. We are looking forward to a great school year!
- On June 26<sup>th</sup> and 27<sup>th</sup> I participated in a Threat Assessment zoom training with NDE. I had attended this is person two years ago, so this was a good review.
- We completed the work on this round of the COPS Grant to replace our current surveillance camera system with a new updated digital system. We will not be recipients of the grant for this go around. That is the bad news. The good news is we are in the bottom tier of needs as our school is safe and not in urgent need of interventions. We will try again next go around. Our next grant project will be for the new dish washing machine in the cafeteria. That will be around the \$20,000.00 mark.
